The President's Corner

The PMI Portland Chapter enjoyed a great birthday party March 18 on the occasion of our 25th Anniversary celebration. There were over 200 attendees, including nine past presidents: Rob Breitbarth, Don Adamski, Rodger Clawson, David Shirley, Chuck White, Jake McMichael, Lee Hall, Connie Plowman, Cynthia Miller, and founder Cliff Gray. Also, there were two past chairpersons of the International PMI Board of Directors, Ken Hartley and Linda Vella. Ken was President of the PMI International organization in 1983, the year of our founding, and as such, was the approving authority of our charter.

Linda Vella, immediate past chair of the International Board of Directors, provided an inspiring keynote address entitled, "The Value of Project Management" in which she summarized the development and growth of the PMI organization over the years. In 1983 the year of the Portland Chapter founding, the entire PMI membership was less that 5000 and largely confined to North American. Today, the membership is over 260,000 in 171 countries. Mathematically, the Portland chapter has increased membership in direct proportion to the rate of growth of the PMI National membership. It is important that we recognized our significant 25th anniversary milestone because the Portland Chapter is representative of the growth and success of PMI.

Why is this important? Professional organizations offer the opportunity for education, certification, recognition, guidance, influence, friendship, networking, camaraderie, and national and international job opportunities. But, only if it is well organized, well managed, and recognized as a leader in the profession. PMI is that type of organization.

PMI has continued to earn worldwide respect and has gained increased professional recognition and influence in the project management profession each successive year. The PMI National Envisioned goal of: "Worldwide organizations will embrace, value and utilize project management and attribute their success to it" is a reality.

I would like to thank the team that worked very hard to make this a very memorable event. Regrettably, several of our leaders were called out of town: Anniversary Chairman Alan Strong, VP of Programs Tim O'Connor, and President Elect Dianne Johnson. However, their roles were particularly well performed by Director of Events Terri Hagmann, Director of Registration Kevin Nichols, Director of Programs at large Emily Rice, and Director of Volunteers Elisa Mene who did an exceptional job as Alan Strong's backup.

Dealing with Difficult People

Passive? Aggressive? In a bad mood, or just plain ornery? When you are dealing with a stressful project and a difficult person at the same time, the label doesn't really matter. It's up to you to put out the brushfire and calm everyone down. Even better is the ability to anticipate, to recognize personality types and communication styles (your own as well as others) and prevent situations escalating to crises.

Identify quickly what you're dealing with and have a few strategies up your sleeve:

- Recognize what makes people difficult in the first place
- Identify the roles and cast of players in this drama
- Discover your own behavior challenges
- Turn conflict into collaboration, emotion into reason


About the Presenter

Managing multiple projects requires an organizational framework in addition to personal skills. Therefore, this class also looks at how project management methodology, governance, and organizational structure affect the management of multiple projects.

Roundtable West May 16 Meeting

Realizing the Promise of Project Portfolio Management – A Framework for Delivering Value

The challenge for project management is to shift from a focus on tactical delivery to driving strategic value. This means managing projects as an element of a larger closed loop benefit realization system that tracks project value through to organizational results. Conventional thinking and traditional process maturity models have resulted in a focus on linear development of project management capability. The demand that shared service organizations operate like a business within the business and as strategic business partners to their business customers requires that PMOs shift from evolving capability along a linear path to comprehensive development of various core capabilities.

This presentation introduces the PM Value Framework™ a tool specifically designed for use by project management professionals working to develop value driven Project Management Organizations. It identifies four core capability areas and supports their integrated development for maximum strategic value. The framework is highlighted in case studies of two PMOs, a mature but struggling organization leading a financial recovery and a start-up with a directive to focus on value defined best practice. The presentation is designed to support all project management professionals in the quest to deliver value at every level of the organization and balance internal best practice with external priorities and value drivers.

Book Review

THE ONE-PAGE

COMMUNICATE AND MANAGE ANY PROJECT WITH A SINGLE

CLARK A. CAMPBELL


The One-Page Project Manager: Communicate and Manage Any Project with a Single Sheet of Paper

By Clark A. Campbell

Published by John Wiley & Sons, Inc., 2007, 140 pages

When I first ran across the title, <u>The One-Page Project Manager</u>, I was skeptical. How could all the information for managing a project fit on one page? After reading the book, my suspicions were confirmed, but the book did give some useful guidance. Most of this book is a how-to guide built around a one-page status reporting template. I've included the template image below, or you can go online to see various versions at www.onepageprojectmanager.com.

But the book also explains a bit about what else the project manager should be doing while completing the template. For example, the author explains the difference between a project





In addition to being management size, each task should be distinct... You can't have accountability if it is hard to tell where one task ends and another begins...Tasks should be measurable in terms of their progress so you can gauge their advancement and report on them...

Throughout the book, the author reiterates the limitations of the one-page spreadsheet. He maintains that it's primarily a way to communicate a complete high-level picture of the project's work and status to executives and sponsors, and advises PMs to also use other tools, such as project scheduling tools, quality plans, etc.

As an executive briefing tool, the spreadsheet seems to me to be a bit busy and would require that recipients have some preliminary orientation to be able to understand the specific meaning of terms like "objectives", "owners", "subjective tasks", and the symbols used.

Here is a summary guide to reading the example that appears on the next page:

Area	Contents

Left Side	Project Objectives mapped against Major Tasks
Upper Middle	Major Tasks with Status by Time Periods
Lower Middle	Subjective Tasks (quality criteria) mapped to Owners/Priorities
Upper Right	Owners/Priorities by Major Tasks
Lower Right	Budget vs. Costs in bar chart format
Bottom	Summary & Forecast in text format



This is a solid, simple book for a beginning PM or part-time PM, who needs a one-stop document to help the project team and other stakeholders plan, apply and monitor the various aspects of the project.

Pros: Very fast read, useful, some general PM tips especially for communicating "up, down and out". The tool is an MS Excel spreadsheet available for free from the website.

Cons: Unclear on differences and connections between types of objectives and subjective tasks. Examples of supplementary information, such as task dependencies, risk management, etc., are not presented, and processes for using these with the tool are missing. Book is only two-color (black & blue), but use of colors is highly encouraged.

Audience: Beginning to intermediate project managers




